# DEBATE COMPETITION

## GUIDELINES

- Each participant shall be given 2 minutes to present their motion.
- After a participant has concluded their arguments, the opponent may pose a cross-question.
- The participant shall be given 30 seconds to answer the cross question posed by the opponent.
- No follow-up questions are permitted, except according to the discretion of the judges.

- Participants may use either English or Malayalam to present their positions.
- Participants are expected to use legal reasoning, facts, and data to substantiate their arguments.
- Participants shall use paper and pen to write notes, however, the use of mobile phones or other electronic gadgets is not allowed.
- In the event of a disagreement, the decision of the judges will be binding and final.
- The topic of the debate will be disclosed on 26th September 2022.
