

Topic : Lien – Carrier’s Prerogative

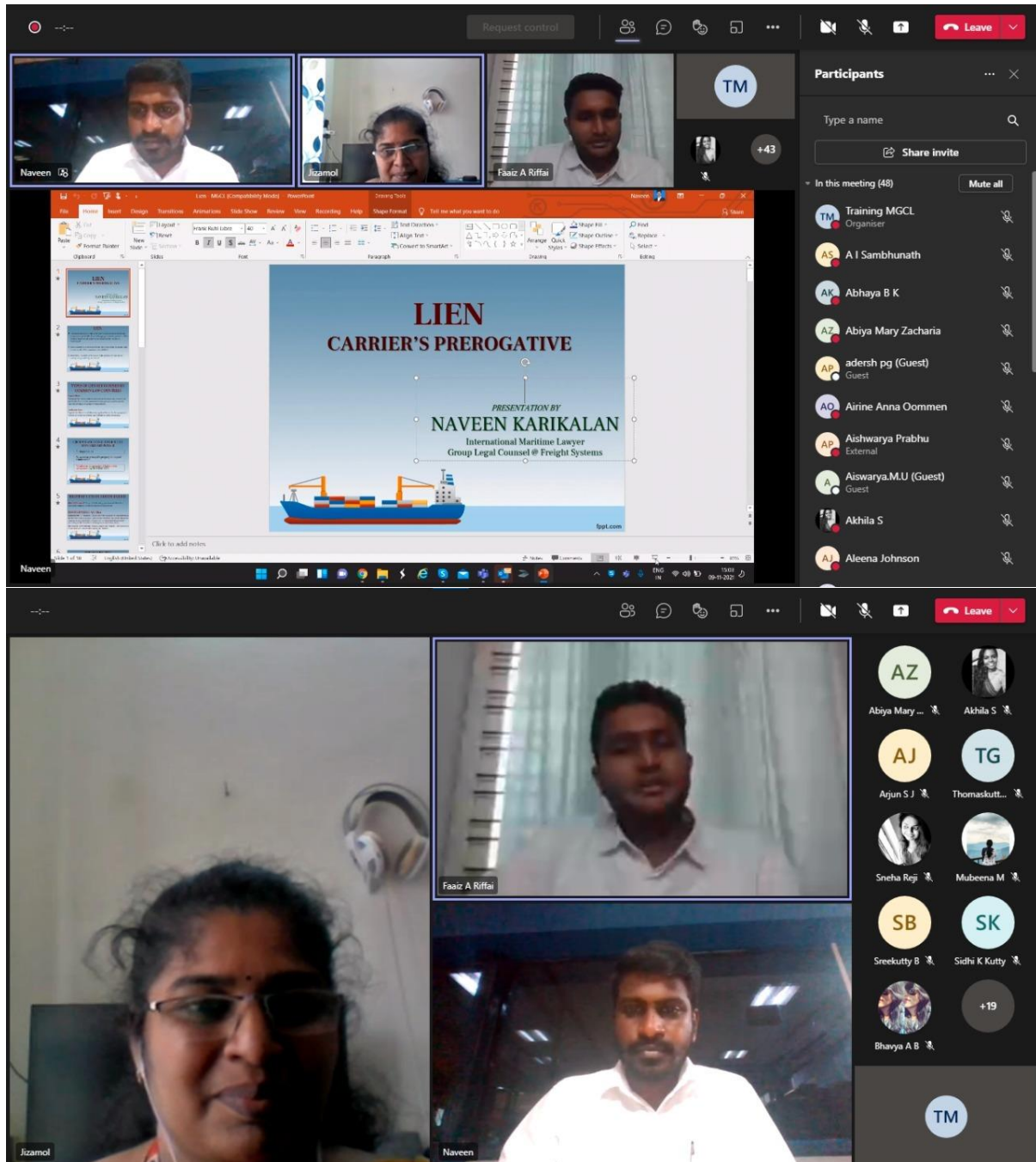
Speaker : Naveen Karikalan, International Maritime Lawyer Group Legal Counsel at Freight Systems.
