- 1. Mr. 'X' was staying in a rented home owned by Mr. 'Y', Mr. 'X' got a gold chain from the rented home premises and handed over to the police. The police could not find out the rightful owner and hence delivered it to Mr. 'Y', the owner of the house. Mr. 'X' filed a suit for recovery of the gold chain which he entrusted to the police, Decide.
- 2. A poisonous gas stored in a company 'X' leaked accidentally and thereby caused nausea, suffocation and created panic among people living in a nearby housing colony. Some of the persons hospitalised. Certain public spirited citizens living in that housing colony went against the company in the court. Company maintained the defence that the incident occurred due to accident and hence they have no liability, Decide.
- 3. Mr. 'X' was a cashier of 'Y' mining Pvt. Ltd. It was part of his duty to take every week's cash collection from his office and deposit it in a nearby bank. While doing so, Mr. 'X' was robbed and murdered. His widow claimed damage under Workmen Compensation Act. The Act provided that when a workman meets his death by an accident arising out of the course of his employment, the legal representative can claim compensation. Company rejected the claim contenting that the incident (murder) is not an 'accident' as per the definition provided under the Act, Decide.
