- (b) Ms. X has handed over her financial information, including bank details to her employer, a Company. Due to the negligence of an employee, such information leaked out and caused grave loss to Ms. X. Discuss the liability of Ms. X's employer.
- (c) A film company find that someone has uploaded their latest movie in its entirety to YouTube. Examine the remedies that can be availed by the company.
- (d) Ms. B bought a new anti-virus CD and stored a copy of it in her personal computer. Is she guilty of copyright infringement? Decide.
- (e) Bindia Bank wrongly debited Rs. 2 lakhs from its customer, Mr. Z, while he was using internet banking services provided by the Bank. He informed the bank about it, but they have refused liability. Discuss possible remedies that may be explored by Mr. Z.
