PART – III

Answer **any four**. Each carries **6** marks.

1. Mrs. X was convicted for abetment of rape and prostitution. She was of 24 years of age and she was a first time offender. She approached the court for probation and the same was ordered in favour of her. Aggrieved by this the victim approached the High Court challenging the order of the lower court. Decide.
2. Investigating officer suspected some electronic records relating to the offence there in the possession of brother of the accused residing in Sri Lanka. The investigating officer was intending to make a search and seizure of the document from there. Discuss the possibilities for the same under the Code.
3. Mr. A was acquitted from the charge under S. 302 IPC by the High Court. Against the judgment of the court the state did not prefer an appeal. Aggrieved by this the brother of the deceased approached the Supreme Court with an SLP. Decide on the admissibility of the same.
4. For taking some consumables from a shop without the permission of the shopkeeper Mr. K who was 17 years of age was assaulted and grievous hurt was caused by the shopkeeper. Shopkeeper was committed for trial. Now there was an option for compounding the offence. Discuss the procedure and possibilities for compounding the offence.
5. A, a Hindu man married B and subsequently married C during the pendency of first marriage. Later he deserted second wife who filed a maintenance petition under the Code. Discuss its maintainability.

1. Critically examine the effectiveness of provisions relating to victim protection in India.
2. Discuss different criminal courts constituted and its jurisdictional limits in India.

4. Make a detail note on the following :
 - (a) Examination of witness by police
 - (b) Rights of accused under CrpC.
