  2. Shri Niranjan, a male Hindu, dies intestate. Only heirs left behind by him were his two sons. One of his sons converted to Christianity before the death of Shri Niranjan. Advise the heirs as to inheritance of property as per Hindu Succession Act.
  3. Smt Devayani, a female Hindu, dies intestate leaving behind two sons and husband. Decide how heirs would inherit her property.
  4. Mr. Hussain, a Muslim male, dies leaving behind no heirs. Who would the property vest with? Decide.
  5. Mr. Sam, Christian has three children John, Mary and Henry. They all die before the father, John leaving two children, Mary three and Henry without children. Afterwards Sam, dies intestate, leaving those grandchildren and no descendant. Decide the question of inheritance.
