1. Write a note on doctrine of pleasure.
2. Discuss the role of Council of ministers under the Indian Constitution.
3. Critically examine the powers of the Supreme Court under Article 142 of the Indian Constitution.
4. Critically evaluate the constitutional provisions related to financial relations between the Union and States.
5. Write a note on constitutional provisions related to Administrative tribunals.
6. Discuss the role of Finance Commission.

III. Answer any **four** questions. Each question carries 6 marks.

1. A Money Bill passed by the Houses is sent to the President for his assent. Advise the President as regards his options.
2. A petition has been filed against the appointment of person who is not a member of either House of Parliament as the Prime Minister for six months. Decide the constitutional provision that would be applicable in the instant case.
3. Parliament decides to take away the power conferred on the High Courts under Article 226 of the Indian Constitution. Decide whether the Indian Parliament has such a power conferred under the Constitution.

4. A writ petition has been filed in the High Court to issue a writ of certiorari to another High Court. Advise on the constitutional prohibitions against the same.
5. The services of a temporary government servant was terminated after holding an inquiry into charges of bribes against him, but a reasonable opportunity to defend himself was not provided. Decide whether the order is punitive and whether it is constitutionally valid.

IV. Answer any **two** questions. Each question carries **12** marks.

1. Whether by virtue of Article 105 of the Constitution a Member of Parliament can claim immunity from prosecution on a charge of bribery in a criminal court?
2. Discuss the provisions related to emergency under the Indian Constitution.
3. Trace the constitutional history in the development of the basic structure doctrine.
