1. 'X', a Muslim lady makes a gift of certain properties in favour of her nephew on condition that he shall pay her Rs. 1,500/- per month for her maintenance. Is the gift valid ? Give reasons.
2. The surviving members of a Sunni Muslim are widow, mother and two son's daughters. Distribute the estate. Give reasons.
3. 'X' a Christian died intestate leaving widow and 4 grandsons. Distribute the estate with reasons.
4. A, a Hindu female died leaving husband Father, Mother, two son's daughter. Distribute the estate. Give reasons.
5. A Sunni Muslim makes a will in favour of A, B and C in the ratio of $\frac{1}{2}$, $\frac{1}{4}$ and $\frac{1}{4}$. All the legatees are non-heirs ? Is the Will valid ? Give reasons. Is there any difference between Shia law and Sunni law regarding the distribution of the property covered under the Will ? **(4x6=24 Marks)**

1. What are the rights of coparceners ? What is meant by coparcenary with in a coparcenary ?
2. What are the subject matter of partition ? How a partition is effected ?
