 - (b) Mr. X, an Indian computer scientist, is a member of a terrorist organization. He breaks the security details of a University website in India and puts up anti-national slogans. Identify the crime committed by Mr. X and discuss his liability under the Information Technology Act, 2000.
 - (c) While Mr. R is in the employment of company, he stole some important computer files from the company and used it to launch his own rival company. Is Mr. R guilty? Clarify. Discuss his liability.
 - (d) Ms. A and Mr. B are parties to a contract whereby Mr. B shall host the website of Ms. A's exclusive online boutique. Mr. B has now secured access to some records containing personal information clients of Ms. A and has handed it over to some friends of his. Determine the scope of liability attributable to Mr. B, as well as the legal consequences of his action.
 - (e) The employee of a hospital in the private sector, Mr. X, was fired by the management. In retaliation, he damaged the servers located in the hospital and deleted all the information stored in electronic format. Advice the hospital as to possible actions against Mr. X.
