  - (a) Mr. Jacob Tharakan, senior software professional employed by GIMPL a reputed software firm registered in Bengaluru was send to USA to test a software programme for a manufacturing company, Twenty above pvt. Itd. which was a client of GIMPL. GIMPL bore all expenses of Mr. Jacob and his wife in USA. Instead of working for GIMPL Jacob made minor alterations in the source code of GIMPL's software and sold the concept of the programme to Twenty above pvt. Itd., consequent to which GIMPL lost its US client. Decide on the liability of Mr. Jacob in India.
  - (b) A prominent religio-political outfit, in the State of Mahalaya in Union of India called out for a hartal in the whole State as a mark of respect to its founder leader, who passed away. Priya, a law student of Mahalaya National Law University questioned the rationality of the total shut down by posting the following comment in Twitter. "People like that found leader are born and die every day and one should not observe hartal for that". Her classmate Shabna liked her post through her own twitter account and shared it. Both were arrested by the police and charged under section 66A of the IT Act of 2000. Advise the accused persons.
  - (c) A prominent actress of Malayalam film industry finds that some unknown people, Posing as her fans have created fake accounts in her name in different social networking sites and have posted defamatory comments and photos. Advise her on the remedies available under IT Act, 2000.
