After coming back home, Shyam develops the same system using a plastic bucket, nylon rope and an aluminium pulley. Can Shyam get a patent for his system under the Indian law?

Is Gyaan in violation of the rights of the performers of the live music concert? Gyaan claims that the work is his original depiction of a real time event. Decide.
- 19. Sangita, a poor student, photocopies a copyrighted work prescribed as essential reading in her syllabus, for the purpose of her studies. Is she liable for infringing the copyright of the original authors?
