- (a) A, during investigation requires search of parcel in custody of the postal department. He applied for search warrant before who is having the local jurisdiction. The magistrate issued a search warrant. The search proceedings were challenged. Decide the judicial first class magistrate.
- (b) X a Muslim women in 2020 marry Muslim male Y. They get divorced in 2021. Does X have right to maintenance after iddat period?
- (c) A, a woman obtained divorce from husband X. She has a child from X. She re-marries B. B dies after one year. She files for maintenance for herself and child from former husband X. Will she succeed?
- (d) A is accused of murder. The police arrests him and as investigation could not be complete within 24 hours, the Police required for custody for 15 days and the magistrate allowed the same. Again after 15 days the Police required for further extension of Police custody for 20 days informing that investigation has been completed; the same was allowed by magistrate. Is further remand to police custody legal? State the law relating to remand.
- (e) Anticipating his death X gave a dying declaration which was validly recorded but X survived. Discuss the scope of statement given by X.
