3. Discuss about witness protection scheme under the B NSS, 2023.
4. Who is eligible and not eligible to get the benefit of probation?
5. Write about bail, bond and surety under B NSS. 2023.
6. Write about joinder of charges under B NSS, 2023.

Explain any **four** of the following. Each question carries **6** marks.

1. S, a victim of a crime, is dissatisfied with the police's refusal to register an FIR. What remedy does S have under the B NSS, 2023?
2. R is arrested and requests to meet her lawyer during interrogation. Can the police deny this under the B NSS, 2023?
3. A police officer conducting a search of a private residence fails to show the warrant to the occupants. Does this breach any provision of the B NSS, 2023?
4. A Police officer conducting investigation of a criminal offence examines orally a person supposed to be acquainted with the facts and circumstances of the case and the same was recorded by audio-video electronic means. The witness claims such recording to be illegal. Decide.
5. An offence of cheating committed using electronic communication is to be tried in the court. What determines the jurisdiction of the court in such cases?
6. In the case of a private complaint, a Magistrate of First Class after examining the complainant on oath proceeds to dismiss the complaint and not take cognizance. Is it lawful for the Magistrate to dismiss the complaint in this manner?

1. What is arrest? What are the do's and do not's of arrest? Elaborate on the rights of the arrested person in light of provisions of BNSS, 2023 and landmark judicial decisions.

3. Discuss in detail the salient features of the Juvenile Justice (Care and Protection of Children) Act, 2015.
