16. A purchased tin food from B. The contents of the tin being poisonous and unfit for human consumption, A's child fell ill and hospitalized. What remedy is available to A?
17. A directs B, his agent, to sell his house at a stipulated price. B informed A that the house could not fetch the stipulated price and bought the house for himself in name of C at a low price. Later B sold the property for a higher price than the earlier stipulated price. Fix the liability of B.
18. B owes to C a debt guaranteed by A. The debt becomes payable but C extends the time for repayment without the consent of A. Later B fails to repay the amount. Is surety liable for the payment?
19. A leaves a cow in the custody of B to be taken care of. Later the cow has a calf. A claims both cow and calf. Decide.
