Whether the defendant is liable to the plaintiff with when he had no contract?
 - (b) The defendant Mr.'A' had dug out coal from plaintiff 'B' s mine unlawfully. On the death of Mr. a, can the plaintiff proceed or continue the action for recovery of value of coal wrongfully taken out against the legal representatives of 'A'.
 - (c) Mr. A was a passenger of Air India. There was some gaps at the base of escalator of the air port and it was not functioning property. The little daughters of 'A' was trapped in the escalator and crushed to death. There was no emergency medical care at the airport. Whether 'A' can invoke the provisions of consumer protection Act.
