- c) Plaintiff had been drawing water from underground for past 60 yrs. The defendant, a farmer sunk a bore well on his land and drew huge quantity of water for personal use which diminished the water supply of the plaintiff. The plaintiff sues the defendant. Decide.
- d) Raj and Kapoor were members of a shooting party. Raj shot a bird but the bullet ricocheted off a tree and hit the Kapoor injuring him. The latter sues Raj for compensation. Decide.
- e) Arun qualified the interview for a managerial post in a company. However when the prospective employer enquired about Arun's antecedents with his former employer, it was conveyed that he was expelled for misappropriating funds of the company. This was true. The prospective employer thus denied employment to Arun. Aggrieved by this Arun sues his former employer for defamation. Advise him. **(4×6=24 Marks)**
