Is Mr. 'X' liable under the Dowry Prohibition Act?
  - (c) The husband of 'R' writes defamatory letters to the superior others where 'R' works. Fed up, 'R' wants to file a divorce. Advice.
  - (d) 'X' and 'Y' are married together for last 15 years. 'X' the wife who is a post graduate in Engineering in being prevented by her husband 'Y' and his mother for pursuing any job. 'X' wants to proceed against 'Y' and his mother. Advice.
  - (e) 'P' and 'G' have been in love for quite long period. Due to constant emotional torture and subordinates 'P' the girl withdraws from the relationship. In retaliation 'G' attacks 'P' with acid. 'P' wants to proceed against 'G'. Advice.
