
ORDER

The Government of Kerala vide paper read (1) above, had issued orders that two seats be created in all Law Colleges, over and above the existing sanctioned strength, subject to the approval of the Bar Council of India, for admitting students belonging to the transgender community and intimated the same to Bar Council of India vide their letter dated 06.08.2025.

The Hon'ble High Court of Kerala, vide paper read (2) above, passed an interim order directing Bar Council of India to grant approval to the request made by the Government of Kerala, vide communication dated 06.08.2025 for creation of two additional seats for transgender students in all Law Colleges across the State.

Bar Council of India, vide paper read (3) above, in exercise of its powers concerning standards of legal education and to comply with the judicial directions for Academic Year 2025-26 granted interim approval to the Government of Kerala proposal for two supernumerary seats in the three year LL.B. Degree Course as well as in the five year Integrated LLB programme in each Law College in Kerala for the Transgender Category for Academic Year 2025-26. Further mentioned that the seats shall be over and above the existing sanctioned intake and shall not reduce or disturb the seat matrix of other categories and that the interim approval covers Law Colleges in Kerala approved by Bar Council of India to impart legal education during the Academic Year 2025-26.

The Commissioner of Entrance Examinations, vide paper read (4) above, sought approval of the University to conduct admission of students from the transgender community in the affiliated colleges.





26 in all affiliated law colleges, as approved by the Bar Council of India, and subject to the following directions of the Bar Council of India.

- The Colleges shall maintain faculty student ratios infrastructure and other BCI legal education norms and the supernumerary seats hall not justify any dilution of minimum standards.
- Principals shall ensure non-discrimination, a safe campus environment and reasonable accommodation measures including identification and name recognition and access to facilities for students admitted in this category.
- Implementation reports shall be forwarded to the University with a copy to Bar Council of India, within seven days of each admission round showing sanctioned intake category wise allotments, names or roll numbers of candidates admitted against the two supernumerary seats and pending vacancies if any.

Orders are issued accordingly.
